**WaterCan Walk for Water Agreement, Release and Indemnity**

PLEASE CAREFULLY READ THE FOLLOWING BEFORE COMPLETING AND SIGNING

In consideration of being permitted to participate in the WaterCan Walk for Water (the "Event"), I hereby declare, agree and confirm as follows:

1. There is no medical reason that would restrict my ability to participate in the Event.
2. I agree to the use of my picture, name and/or city/town of residence, without compensation, for publicity reasons.
